

Fairy Godmother Application



TVCRN is a strength-based child abuse and prevention program serving families with infants and toddlers in Malheur County. Our program is based on the highly successful relief nursery model developed over more than 30 years and implemented in 15 communities across Oregon. While the cornerstone of this model is the therapeutic classroom, another key component is our home visiting program. The interventionists who conduct these visits see firsthand how greatly in need some families are and want to do more for them. The Fairy Godmother program helps us to do just that – fulfill some of the unmet needs of children, such as warm clothing, shoes of the right size, and diapers. Because children have a need to experience joy and delight, Fairy Godmothers also may provide something such as a toy or book. Fairy Godmothers also may help their family in an emergency situation.

The Fairy Godmother program is open to anyone who would like to give in a personal way, knowing something about the beneficiary of their donation and giving in a way that directly meets a child's needs. Interventionists are allowed to give updates on the well-being of children and families without using names, for confidentiality reasons. "Fairy Godmothers" are welcome to check with their child's interventionist to set up a time to visit their child during class. Parents of the child are notified that their child has a Fairy Godmother. The interventionist will facilitate any communication or interaction between Fairy Godmother and parent/child (such as thank-you cards, questions about a child's needs, etc.). Because the interventionist will be sharing some information about the child and his/her family with the "Fairy Godmother," we require all applicants to sign our Statement of Confidentiality.

Statement of Confidentiality:

As an authorized volunteer for Treasure Valley Children's Relief Nursery, I may have access to privileged information and thus I am subject to the same code of ethics as TVCRN staff and classroom volunteers. I understand that it is my responsibility to: (Please check each box.)

- Protect the privacy of children or families about whom I may have confidential information;
- Not reveal confidential material to persons other than TVCRN staff;
- Not talk about children or families of TVCRN in places where other may overhear the conversation;
- Realize that not all information about the children or families can be shared with me.

I understand the above policies, and agree to always uphold them as a TVCRN volunteer. I further understand that any information obtained as a TVCRN volunteer is still considered confidential, even after I have terminated my volunteer/"Fairy Godmother" status.
